Upon receipt Appeal to Honor a written complaint of an alleged Honor Code violation, the coordinator or an investigator will notify the student by letter that he or she is the subject of an Honor Code investigation, and an investigator will be assigned to investigate the alleged violation. If these penalties are assigned to a student who has also been Appeal to Honor the penalty of suspension, he or she will be required to contact the Office of Student Accountability and Restorative Practices upon re-enrollment during the first week of the semester back at JMU.
